MINUTES OF A REGULAR MEETING OF THE MAYOR AND CITY COUNCIL

The Mayor and City Council of the City of St. Martinville, Louisiana met in Regular Session on the 2nd day of October, 2023 at City Hall, their regular meeting place, pursuant to the call of the Mayor.

Mayor Jason Willis presiding, called the meeting to order.

It was moved by Mike Fuselier duly seconded by Janise Anthony and unanimously carried that the minutes of the regular meeting held September 18, 2023, hereby be approved for publication in the Teche News, the Official Journal of the City of St. Martinville.

Upon motion of Jonas Fontenette duly seconded by Mike Fuselier and unanimously carried that the bills to be paid by the City Finance Committee hereby be approved for payment.

ORDINANCE 23-05

An Ordinance by the City Council of the City of St. Martinville

WHEREAS, the City of St. Martinville has previously adopted rules and regulations by ordinance relating to the Historic District of the City, and

WHEREAS, the City Council has determined that certain amendments are appropriate to accommodate the efficient administration of the Historic District.

THEREFORE, be it ordained that the following Miscellaneous Ordinance is adopted, amending a replacing the original provisions related to the same subjects:

Authorized Parties to Apply for Certificates of Appropriateness

Certificates of Appropriateness constitute an agreement between the property owner of record and the St. Martinville Historic District Commission, thus only the property owner of record can submit a certificate of appropriateness for approval. Individuals with rental, rent to own, or any other form of property residency agreement, other than that of recorded ownership, are not authorized to submit a certificate of appropriateness, unless the owner of record and the secondary party enter a legally binding agreement by which the owner of record and the secondary party agree that the secondary party is authorized to enter such agreements, and understands by doing so, is taking responsibility for required repairs and restoration, as per the articles of the St. Martinville Historic District Commission. Furthermore, the owner of record understands and agrees that by entering such an agreement, they forfeit the right of directive in terms of materials, methods, and color palette utilized in fulfilling the required restoration. Any form of agreement will require witness and authorization by a legally recognized notary public.

Window Tinting and Window Coverings

Window tinting is acceptable in the historic district under the following guidelines:

- The degree of window tint will not exceed 35% and the window tinting will not obscure the sidewalk view of the building interior, with the only acceptable means being curtains, blinds, or shades with the ability to be opened and closed.
- The color of the window tinting will be charcoal grey, bronze, or within a similar color palette. Under no circumstances is colored window tinting acceptable, i.e., red, blue, green, purple etc.
- During periods of construction, cardboard or paper covering over windows is acceptable, though will be immediately removed once construction is completed and replaced with an acceptable means of window covering, i.e., tinting, curtains, blinds, or shades. Under no circumstances is paper covering to be maintained on buildings during periods of soliciting rental, sale, occupancy, or periods of vacancy.

Vendors will be set up around the Evangeline Oak.

It was moved by Mike Fuselier duly seconded by Jonas Fontenette and unanimously carried that the utility gone list/ uncollectable bills for 2023 in the amount of \$ 30,834.42 be written off, however collections were not waived.

Upon recommendation of CRT Director Danielle Fontenette, it was moved by Mike Fuselier duly seconded by Janise Anthony and unanimously carried that Esther Perkins be hired as part-time docent with a rate of pay of \$10.30 per hour.

Upon recommendation of Chief Ricky Martin, it was moved by Mike Fuselier duly seconded by Janise Anthony and unanimously carried that the position of Lieutenant be created with a pay of \$42,500.00 annually.

Upon recommendation of Chief Ricky Maritn, it was moved by Mike Fuselier duly seconded by Jonas Fontenette and unanimously carried that Sgt Andrew Broussard be promoted to Lieutenant with a pay rate of \$20.43/hr. This appointment is a provisional appointment.

Upon recommendation of Chief Ricky Maritn, it was moved by Jonas Fontenette duly seconded by Janise Anthony and unanimously carried that Emily Segura be promoted to Records Clerk with a pay rate of \$14.30/hr. This appointment is a provisional appointment.

Following successful completion of the Police Civil Service test, it was moved by Mike Fuselier duly seconded by Jonas Fontenette and unanimously carried that Jory Gary be promoted to Sergeant in Patrol with a pay rate of \$18.90/hr.

Upon recommendation of Chief Ricky Martin, it was moved by Mike Fuselier duly seconded by Janise Anthony and unanimously carried that Eligous Ledet be hired as full-time Police Officer with a pay rate of \$16.57/hr.

Priority #5 New city barn and service storage for barn equipment/ vehicles	\$ 800,000
