City Council meeting 11-6-2023

Mr. Purvis Morrison of La Louisianne Consulting Firm gave an update on the work being performed by the firm. Mr. Morrison advised that all paperwork has been filed for the Capital Outlay Priority request. He further informed the council of funds that may be available for the City to establish a charging station for vehicles.

Mr. George Choplin updated the council on plans for the City Christmas Parade scheduled for Sunday, December 10th at 2:00pm beginning at SMSH and ending on Denier Street near the old Fred's store.

It was moved by Carol Frederick duly seconded by Janise Anthony and unanimously carried that approval be granted to hold a Christmas Festival in front of City Hall on Sunday December 10th following the Christmas Parade.
