The Mayor and City Council of the City of St. Martinville, Louisiana met in Regular Session on the 6th day of May 2024 at City Hall, their regular meeting place, pursuant to the call of the Mayor.

Ordinance 24-01

ORDINANCE TO AMEND THE CHARTER OF THE CITY OF ST. MARTINVILLE TO CHANGE THE DATE FOR SETTING SALARIES FOR MAYOR AND COUNCIL

An Ordinance by the City Council of the City of St. Martinville Amending the City Charter with respect to salaries of the Mayor and Councilmembers

WHEREAS the City Charter for the City of St. Martinville contains an antiquated provision regarding both the maximum salaries and the deadline to set the salary for the Mayor and Council for the ensuing year, and

WHEREAS, the City Council has determined that it would be more effective to coordinate the date for setting of such salaries with the dates in place for establishing and approving the City Budget, and allowing the Council to set salaries without the necessity of amending this Charter,

THEREFORE be it ordained that the following Ordinance amending City Charter for the City of St. Martinville is adopted:

Article II (9.) is amended to read as follows:

"[2] [Salaries of Councilmembers and Mayor.] The Council Members shall receive such salaries as the majority of the Council may determine."

Article IV (2.) is amended to read as follows:

"[2] [Salaries.] The town council shall, on or before the first day July, fix the salaries and fees of the mayor, and other elective officers, and shall at that time establish the compensation or salary to be paid to the officers appointed by the town council."

This amendment to the Charter of the City of St. Martinville shall become effective as amendments to the Charter upon approval by the Governor under La. RS 33:1181 and recording in the office of the Louisiana Secretary of State.
