City Council meeting 12-02-2024

Mayor Willis gave an update on the work being performed by Sides & Associates on the City website.

Street closure and parking fines for the 2024 Christmas Parade were discussed. No action was taken.

It was moved by Janise Anthony duly seconded by Carol Frederick and unanimously carried that the City Council go into executive session to discuss the following:

- Employment status change for Derek Fontenette
- Employment status change Dana Chevalier

The City Council reconvened after executive session upon motion of Carol Frederick duly seconded by Janise Anthony.
