WHEREAS, the City of St. Martinville owns and operates a wastewater collection and treatment

system; and

WHEREAS, the Louisiana Department of Environmental Quality (LDEQ) requires that the City of

St. Martinville complete an annual Municipal Water Pollution Prevention Environmental Audit Report

(MWPP) for the City's wastewater collection and treatment system.

NOW, THEREFORE, BE IT RESOLVED that the City of St. Martinville informs LDEQ that the fol-

lowing actions were taken by the City Council:

1. Reviewed the City's MWPP Environmental Audit Report for the period of January, 2024

through December, 2024, which is attached to this resolution.

2. Set forth the following actions necessary to maintain permit requirements contained in the

City's LPDES Permit (Number LA0040941):

a. Continue the City's current program of inspecting and repairing components of the City's

wastewater collection system, to reduce storm water inflow and infiltration;

b. Continue to operate and maintain the City's existing treatment facility and make repairs thereto as may be necessary, so as to meet effluent limitations in accordance with the

City's LPDES Permit.

ST. MARTIN PARISH, LOUISIANA A RESOLUTION OF THE CITY OF ST. MARTINVILLE AUTHORIZING THE EXECUTION OF THE LEGAL SERVICES' AGREEMENT RELATED TO AFFF/PFAS LITIGATION SERVICES

WHEREAS, the City of **St. Martinville** ("the City") is committed to delivering clean drinking water to its customers; and

WHEREAS, the City is also committed to identifying parties and taking reasonable steps to avoid passing on the costs to its consumers for the treatment and remediation of contamination; and

WHEREAS, STAG LIUZZA, L.L.C. has put together a team of uniquely qualified and experienced attorneys (the "Firm") who have joined together to assist public entities facing the challenges posed by contamination with per- and polyfluoroalkyl substances ("PFAS"); and

WHEREAS, the Firm is comprised of experienced attorneys in both in PFAS litigation and in the representation of public entities and water suppliers in cases involving groundwater contamination; and

WHEREAS, the City has determined it to be in the City's best interest to enter into the Agreement with the Firm and pursue any claims it may have related to PFAS; and

WHEREAS, the City desires to authorize the execution of the as Contract; and

NOW THEREFORE BE IT RESOLVED that the Mayor is hereby authorized to execute the Legal Services' Agreement with the Firm based upon the terms and conditions set forth herein and, in a manner, substantially similar to the Agreement attached hereto as Exhibit "A."

It was moved by Councilman Fuselier duly seconded by Councilwoman Frederick and unanimously carried that the property owned by Burton Willis c/o Marilyn Hogan located on Parcel # 17201C2112 of Cemetery Hwy be declared a dilapidated trailer and a nuisance based on the report provided by City Inspector Rodney Richard.

The dilapidated/adjudicated property located at 130 Labbe and 211 E. Hyacinth was discussed. The general consensus was to consider using the services of E&P Consulting Services, LLC to sell property that has been adjudicated to the City.

It was moved by Councilman Fuselier duly seconded by Councilwoman Chatman and unanimously carried that Mayor Willis be authorized to execute Cooperative Agreement with Wesly Johnson of E&P Consulting Services, LLC for the sale of adjudicated property.

No action was taken regarding outdoor recreational events on City property. CRT Director Danielle Fontenette will continue to research how other communities handle events.

It was moved by Councilwoman Flo Chatman duly seconded by Councilman Fontenette and unanimously carried that permission be hereby granted to close Evangeline Blvd and South New Market Street to hold the Annual Acadian Memorial Festival on Saturday, May 17, 2025 as a result of the cancellation for March 15th festival due to weather. Permission was also granted for the sale of alcohol.

Upon recommendation of Chief Ricky Martin, it was moved by Councilman Fontenette duly seconded by Councilwoman Flo Chatman and unanimously carried that Jackilyn Lee be hired as full-time Post-Certified Police Officer, with a pay rate of \$18.22/hr.

A RESOLUTION REGARDING SEWER RATE STUDY

WHEREAS, the City of St. Martinville received grant funding from the Louisiana Office of Community Development to upgrade the city's sewer infrastructure; and

WHEREAS, the grant required that the city have a current rate study performed and requested that the city work with EAG Public Sector, LLP to complete a sewer rate study; and

WHEREAS, EAG Public Sector, LLP submitted Sewer Rate Study Final Report and the Rate Study Forecast Model for St. Martinville to the City of St. Martinville on March 21, 2025; and

WHEREAS, the rate study reflects no rate increase is required for FY 2025, however, the study does recommend that the sewer rates be reevaluated for a possible increase in 2027

NOW THEREFORE BE IT RESOLVED, that Mayor and Council accept the rate study and will reevaluate the rates in 2027.

ORDINANCE 25-05

An Ordinance by the City Council of the City of St. Martinville with regard to the office of Deputy Chief of Police

WHEREAS the City Council of the City of St. Martinville has previously determined that the creation of the office of Deputy Chief of Police, pursuant to the authority of the Louisiana Legislature in Title 33, Section 2541, has determined that it is in the best interest of the City in the efficiency of the Police Department to create the office of Deputy Chief of Police of the St. Martinville Police Department, and

WHEREAS the Council previously voted July 21, 2014 to create the office of Deputy Chief upon motion of Craig Prosper with unanimous second of all Council members, a quorum being present, and unanimously passed, and

WHEREAS the Council desires to make certain modifications and improvements with regard to the position of Deputy Chief of Police,

THEREFORE be it ordained that the action of the City Council taken by lawful vote at its regular meeting of July 21, 2014, is hereby ratified and confirmed, and Section 16.5-53 of the Code of Ordinances for the City of St. Martinville be and the same is hereby added and supplemented, as follows:

Section 16.5-53. **DEPUTY CHIEF OF POLICE.** Pursuant to the authority of Louisiana R.S. 33:2541.1, the position of Deputy Chief of Police is hereby created, to be administered in accordance with the provisions of Title 33 of the Louisiana Revised Statutes. If the City Council determines there is a need for a Deputy Chief prior to the filling of the position according to law, the Council may appoint an Interim Deputy Chief of Police.

A Resolution by the City Council of the City of St. Martinville supporting legislation to create an Economic District within the City of St. Martinville

WHEREAS the City Council of the City of St. Martinville believes that the creation of a separate economic and development district within the city limits of the City of St. Martinville will increase the ability of the City to attract and support businesses and industry within the City of St. Martinville, and

WHEREAS Representative Marcus Bryant has introduced House Bill 107 in the 2025 Session of the Louisiana Legislature to create such an economic district,

THEREFORE be it resolved that: the Mayor and City Council of the City of St. Martinville support the creation of a Greater St. Martinville Economic Development District within the City of St. Martinville, said District to include all blocks fronting on Main Street within the city limits of the City of St. Martinville, as currently existing or as hereafter expanded, together with the Adam Carlson/Southside City Park and all lands fronting on the boundaries of said Park, the Historic City Square, including Evangeline Boulevard, Catfish Alley, and South New Market Street, all blocks fronting on East Bridge Street from Main Street to the eastern city limits of the City, and Port Street from Main Street continuing westerly to the westerly city limits.
